Southwest Holly Springs Historic District

The fifty-acre Southwest Holly Springs Historic District is an irregularly shaped neighborhood located south and west of the Holly Springs Courthouse Square Historic District. The area south of the square is laid out in a well-defined grid plan which assumes a less formal pattern west of Craft Street. The proposed district is characterized by tree-lined streets and large, well-landscaped yards. Each of the eighty properties located within the proposed district is used for residential purposes.

Individual resources included in the Southwest Holly Springs Historic District are categorized as follows:

- P Pivotal buildings which appear to qualify for listing in the National Register of Historic Places by reasons of individual architectural or historical significance.
- C Contributing buildings which promote the architectural significance of the district.
- M Marginal buildings which do not contribute to the architectural significance of the district at this time but may gain significance at some point in the future. Marginal buildings by their scale, materials or setting do not detract from the character of the district.
- I Intrusive buildings which detract from the architectural significance of the district and interrupt the cohesion of the historic environment.

Note: Many of Holly Springs' historic resources do not have street addresses. Other resources have either individual or double addresses, a legacy of the city's three street-numbering systems. These individual and double street addresses, many of which appear to be out of sequence, are included if known. Building numbers assigned in this inventory correspond with those used on the map labeled, "Historic Resources of Holly Springs."

Craft Street

 The Magnolias. Two-story, hip-roof, stucco residence with prominent center front gable. Large lancet window with diamond-paned glass set in gable. Three-bay, hip-roof porch with intricate cast-iron balustrade, posts and frieze made by Jones-McIlwain and Company. Tudor-arched entrance with sidelights. Gothic Revival, 1850. (P)

8 - SIGNIFICANCE

The proposed Southwest Holly Springs Historic District is the second largest of the community's three architecturally significant residential neighborhoods. Outstanding examples of Holly Springs' pre-Civil War Greek Revival architecture dominate the neighborhood, including the Walter Place (#50), Fort Daniel Place (#42), Fleur-de-Lis (#20) and The Mimosas (#3). Some of the oldest extant homes in the town, built as log dogtrots in the 1830s, and subsequently enlarged and remodeled later in the nineteenth century (#'s 41, 48, 51, 52, 56), are located on West Gholson and Chulahoma Avenues. Featherston Place (#8), Polk-Cochran Place (#9) and Dunvegan (#38) were remodeled with distinctive Georgian Revival details by St. Louis architect Theodore C. Link, initially commissioned by Oscar Johnson, president of the International Shoe Company in St. Louis, to remodel the interior of his Holly Springs home, Walter Place. Locally significant examples of vernacular architectural styles, including Italianate cottages (#'s 7, 40, 49), Bungalows (#'s 12, 37, 45, 66) and folk houses (#'s 73-80), add greatly to the character of the proposed historic district. No intrusions detract from the integrity of the area; even those structures listed as marginal maintain the scale and rhythm of the streetscape.

Verbal Boundary Description:

The Southwest Holly Springs Historic District, an irregularly shaped area of approximately fifty acres, is bounded on the east by the east side of South Center Street and the west side of South Memphis Street; on the west by the east side of Marbury Court and the west side of Craft Street; on the north by the north side of Chulahoma Avenue and the north side of Gholson Avenue; and on the south by the south sides of Chulahoma, Elder and Mason Avenues. District boundaries correspond with the boundary line around shaded area (1) indicated on the Holly Springs Multiple Resources nomination map.
