DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The focus of the Main Street Historic District in Vicksburg is a small triangular plot on a hill at the junction of Main, Locust, and Openwood streets. The center of the plot is marked by a marble horse trough. Around this point stand the larger, commercial and public buildings of the district, with the smaller, residential structures arrayed along the hillside of Locust and Main streets below. The district is composed of seventeen structures, ten commercial and public buildings and seven residences. Most residences date from the 1830s, '40s, and '50s; commercial and public buildings were built between 1840 and 1905. Within the district there is but one intrusion; two recently constructed buildings exist, but they do not detract from the character of the district. All but three of the seventeen structures in the district are architecturally and/or historically significant, and despite incompatible alteration of a few structures renovation has not diminished the overall architectural character of the district. Some original landscape features, such as cast-iron fences and brick-paved streets, remain integral parts of the district. The Main Street Historic District has indeed largely retained its nineteenth century ambience.

In sharp contrast to the character of the district, however, is the composition of the adjacent area to the south, which has changed considerably. The south side of Openwood Street, which once presented a unified facade of storefronts, has now taken on the appearance of a strip development, being occupied by gas stations, parking lots, and separate new structures. Buildings on the north side of a part of Openwood Street just outside and west of the district, while still remaining in a unified block, have been incompatibly renovated to such an extent that their original character has been destroyed.

Buildings Contributing to the Character of the District

1. Montèith-Crichlow House (1206 Main Street). 1852. One-and-a-half-story Greek Revival cottage with undercut gallery. Window surrounds fluted with corner blocks. Front facade flush boarded, with panels below sill level.
2. Constitution Fire House (1204 Main St.). 1870. Two-story three-by-three-bay brick building with hip roof and cupola. Round-arched door openings first floor. Segmental-arched window openings second floor.
3. Kette Block East (1206 Openwood Street). 1886-92. Two-story brick building with canted-corner entrance and arched opening leading to service alley. Second-floor porches front and rear. Corbeled, sawtoothed cornice with decorative open brickwork.
4. Kette Block West (1200-1202 Openwood St.). Ca. 1880. A one-story section connects this two-story building to Kette Block East (above). Facade slanted to accommodate the peculiar angle of street corner. Storefronts have been infilled. Cornices similar to Kette Block East.
5. Gore Hardware Store (1201-1203 Openwood St.). Ca. 1902-1907. Seven-by-four-bay two-story brick commercial block retaining original cast-iron columns. Cornice enriched with corbel table.

STATEMENT OF SIGNIFICANCE

The Main Street Historic District in Vicksburg, which includes what is thought to be the earliest residential and commercial area in the city (V. Blaine Russell, a collection of articles from the Vicksburg Evening Post, June 10, 1930-May 25, 1949, located in Old Courthouse Museum, Vicksburg), is architecturally significant for its concentration of well-preserved Greek Revival residences and nineteenth- and twentieth-century commercial and public buildings, including Christ Episcopal Church, oldest church and probably oldest public building extant in Vicksburg. The low scale of buildings, and amenities such as cast-iron fences and brick-paved streets, contribute to the nineteenth-century character of the district.

Situated on a bluff overlooking the Mississippi River, Vicksburg was first surveyed and divided into lots ca. 1821 from the estate of Newet Vick. After receiving a charter in 1826 and being named the seat of Warren County in 1836, the city experienced a rapid development as a social center for the planting aristocracy (H. P. Chapman and J. F. Battaille, Picturesque Vicksburg [Vicksburg: Vicksburg Printing and Publishing Co., 1895], p. 11) whose prosperity affected city residents generally: "Merchants achieved wealth at an easy rate. [Vicksburg] lawyers shone, a galaxy of talent and learning at a period when the bar of Mississippi was famous throughout the South" (Ibid.). Many prominent men of the period built residences in or near the area included in the Main Street Historic District. Among the residences extant in the district are those of two lawyers, William S. Bodley, who became a circuit judge (1837), and William A. Lake, who was elected state senator (1848) and later U.S. Congressman (1855). The Duff Green House, owned by the wealthy merchant who was the son-in-law of Congressman Lake, served as a Confederate hospital during the Civil War. Served by Christ Episcopal Church, a Gothic structure completed 1843, and the Constitution Fire House, which housed the first volunteer fire company in the city, the area was considered a "central and most eligible" residential location (In and About Vicksburg [Vicksburg: Gibraltar Publishing Co., 1890], p. 139) until 1876, when as a result of flooding the Mississippi River changed course, leaving the central portion of the city for a time without a port. In keeping with "the tendency of the city to follow the river," (Ibid.) the once-fashionable area became the northern limits of the city and somewhat less desirable as a residential location. As a commercial center, however, the area continued to thrive, possibly because of the fact that even after the river changed course Openwood Street remained the main thoroughfare leading to points east, including Jackson, the state capital forty miles away. Openwood Street, which leads to and derives its name from Open Woods, home and burial place of Newet Vick, is the only diagonal street in Vicksburg. Buildings constructed at the point where Openwood Street intersects Locust and Main streets are uniquely designed to accommodate the peculiar angles of the streets, employing slanted fronts and canted corners and creating an intimate grouping around a triangular open space found nowhere else in Vicksburg.

7 - DESCRIPTION

6. Plain Gables (805 Locust Street). 1835. One-and-a-half-story five-by-four-bay frame dwelling with central entrance and symmetrically placed dormers. Greek Revival door surround.
7. Duff Green (806 Locust St.). Ca. 1856-1866. Greek Revival three-story five-by-four-bay brick dwelling with central entrance, two-tiered cast-iron gallery, and bracketed cornice. Separate nomination of this property to the National Register of Historic Places submitted Nov. 17, 1978.
8. Christ Episcopal Church (115 Main Street). Begun 1839, completed 1843; rear addition 1866. Gothic rusticated-stucco-over-brick one-story building with three-story tower enriched with pinnacles, balustrade, and corbel table centrally placed on front elevation, from which a pinnacled entrance bay projects. Corners are buttressed.
9. Christ Church Rectory (115 Main St.). 1871. Italianate two-and-a-half-story brick dwelling constructed on L-plan. Outstanding architectural features include bracketed cornice, bay window, a front porch enriched by millworked Tudor-arched frieze, and central pendants.
10. Christ Church Sunday School Building (113 Main Street). Marginal contribution; see below.
11. William Lake House (1103 Main St.). Ca. 1835. Greek Revival one-story five-by-five-bay cottage with undercut gallery and high basement. Greek Revival door surround with Ionic columns. Hip roof with deck.
12. Church of God (1100 Main St.). Marginal contribution; see below.
13. House (1104 Main St.). Intrusion; see below.
14. Winfield Law Office (1116 Main St.). Ca. 1855. Greek Revival two-story three-by-three-bay brick house with a hip roof and rear wing. Side-hall entrance with simple surround consisting of side lights and transom. Corbeled cornice on front elevation covered by modern denticulated wooden cornice.
15. House (118 Main St.). Ca. 1907-1913. One-story three-by-two-bay shotgun cottage with hip roof and exposed rafter ends. Bracketed posts support undercut gallery. Central entrance.

7 - DESCRIPTION

16. Kory Bakery Building (1131 Openwood St.). Ca. 1870. Two-story three-by-four-bay brick commercial building with high basement and hip roof. Facade slants to accommodate peculiar angle of street. Corbeled cornice. Segmental-arch windows.
17. Store (1127 Openwood St.). Ca. 1880. One-story two-bay brick commercial building with corbeled, denticulated cornice. Original window and door framing set beneath segmental arches.

Buildings Contributing Marginally to the Character of the District

10. Christ Church Sunday School Building (113 Main St.). 1976. Although of recent construction, front-gable brick building employs round-arched windows, color-matched brick, bracketed cornice, and Tudor-arched frieze to blend with Christ Church Rectory Building.
12. Church of God (1100 Main St.). 1946. Two-story three-by-seven-bay structure with front-gable orientation, hip roof, and short steeple. Clad with asbestos siding. Not architecturally intrusive. Good scale and anchor for corner.

13. House (1104 Main St.). 1952. One-story modern dwelling constructed on an L-plan; clad with asbestos siding and brick veneer.
