Spengler Thomas Building Hinds County, Mississippi

Narrative Description

The Spengler Thomas Building is a two-story brick commercial building, built in 1925, located at the northwest corner of Pearl Street and President Street in downtown Jackson, Hinds County, Mississippi.

The building consists of two stories over a full basement and encloses 5400 square feet per floor. It is constructed with perimeter masonry bearing walls, with a floor and roof structure of wood joists. A row of columns down the center of the building provides intermediate support. The columns at the ground level are cast iron with a simplified Doric capitol. These columns are also used on the President Street façade. The second floor columns are wood. The beams between the columns are wood. Floor systems are wood joists at 16" on center.

The President Street façade on the east elevation is the primary façade and consists of a wood storefront on the first floor with double hung wood windows on the second floor. A steel beam on steel columns supports the masonry wall above the storefront. The storefront has undergone alterations through the years but it has recently been returned to its 1925 condition. Entry is through two sets of recessed double doors flanked by plate glass display windows with panels below them and transoms above. An awning of steel angles and galvanized decking spans the front façade and visually divides the first story from the second story. The original brickwork has narrow joints and good quality brick. A pressed metal comice ornaments the top of the façade. It has corbels with acanthus leaf details and sits on a brick base with a corbeled brick cornice below. This elevation retains its original entrances, brickwork, columns, windows and cornice.

The south elevation on Pearl Street is simpler and has seen fewer changes over the years. It is a brick bearing-wall with window openings, including original double-hung and fixed windows. The fine brickwork of the front (east) façade turns the corner, but there the construction changes to that of a utility-grade wall, using lower quality brick with wider mortar joints. An original canopy hangs over the south exit door.

The interiors of the building are relatively intact. The first story retains its original plaster walls, wood window trim, and maple flooring. The first floor ceiling is wood tongue and groove. There is an original freight elevator in the northwest corner of the building, which was used for moving merchandise. On the second floor, the walls retain their original plaster as well as the window and baseboard trim. The front third of the second story is separated from the rest of that story by a partition wall with original doors and transoms. The floor is original tongue and groove pine.

The roof of the building is relatively flat and is surrounded by a brick parapet.

Spengler Thomas Building Hinds County, Mississippi

Statement of significance

Built circa 1907-09, the Spengler-Thomas Building is locally significant under criterion C in the area of Architecture, as one of the best examples of a small-scale early 20th century commercial building remaining in downtown Jackson. It retains a high degree of architectural integrity, especially on the exterior.

The building is located near several other historic structures on President Street, including the Elk's Building (circa 1910) just to the north, the former Central Fire Station (1904-05) (National Register 1975), directly across Pearl Street to the south, and Jackson City Hall (circa 1847-53) (NR 1969), just south of the Central Fire Station. The Spengler-Thomas building is an integral part of the historic fabric of the area and stands as an important representative of Jackson's early 20th century commercial development.

By the early years of the 20th century, Jackson had become a regional transportation hub and a commercial center for central Mississippi. By 1920, numerous small-scale commercial buildings, from one to four stories in height, extended along Capitol Street between the Old State Capitol and Union Station, and along several blocks of State Street and President Street to either side of Capitol Street. Clusters of very early 20th century commercial buildings survive in the small Spengler's Corner Historic District at the eastern end of Capitol Street and in the West Capitol Street Historic District near Union Station. The Spengler-Thomas Building is one of very few surviving early commercial buildings outside of those districts, and it is one of the best preserved commercial buildings from the decade of 1900-1910 remaining in Jackson.

The property where the building stands was bought in 1882 by the Spengler family. The building was built between 1907-1909. It was occupied by Bowers Brothers Dry Goods in 1910. By 1913-14 it had become the location of Maloney Brothers Dry Goods and Grocery Store. In 1916 Maloney Brothers Dry Goods occupied half the lower story and S.N. Thomas Department Store occupied the other half, moving from Roach Street where it had been since 1903. In 1917 Southern Business College operated in part of the upstairs. The other half of the second story served as meeting rooms for a Masonic lodge. In 1922 S.N. Thomas bought the building . By 1923 the Thomas Department Store and Thomas Dry Goods Co. occupied the entire first floor. In 1935 the entire building, except for the Masonic lodge hall, was used by S.N. Thomas' Sons Wholesale Company. In 1939 the retail area was remodeled and maple flooring installed at a cost of \$750. The basement was excavated in 1948. In 1962 the mezzanine area was added. The S.N. Thomas's Sons Company continued to use the building until the late 1990s. In 2000 the building was acquired by Canizaro Cawthon Davis Architects. The firm undertook the restoration of the building, which was completed in 2002.

VERBAL BOUNDARY DESCRIPTION

The nominated property occupies a tract of land situated in Square 10 South, City of Jackson, according to H. C. Daniels map of 1875 Jackson, Mississippi, and being more particularly described as follows:

Beginning at the Northwest comer of Pearl Street and President Street, as both are now in use, and run Westwardly along the Northern right of way of Pearl Street for a distance of 186.00 feet; thence Northerly along a line parallel with President Street for a distance of 26.00 feet; thence Easterly along a line parallel with Pearl Street for a distance of 26.00 feet; thence Northerly along a line parallel with President Street for a distance of 40.83 feet; thence Easterly along a line parallel with Pearl Street for a distance of 160.00 feet to the West right of way line of President Street: thence Southerly along the Western right of way of President Street for a distance of 120.83 feet to the Point of Beginning. This tract contains 21,412.90 square feet or 0.492 acres, more or less.

These are the boundaries define the tract of land historically associated with the Spengler-Thomas Building.
