## **Historic Sites Survey**

ARCHITECTURAL DESCRIPTION:

Halstead Place is a one-and-one-half story wood frame house which rests on brick piers. It is covered with a side gable roof which has a large shed-roofed dormer on its southern slope. A wrap-around gallery which shades the facade and east elevation is supported by square posts; the open eaves expose the rafter tails. The interior walls are sheathed in beaded tongue-and-groove wainscoting.

ALTERATIONS:

Installation of fans in the north (rear) window.

OUTBUILDINGS:

small shed in rear

LANDSCAPE FEATURES:

The large lot slopes down towards the beach, consists of a large pasture dotted with oaks.

STATEMENT OF SIGNIFICANCE:

Halstead Place is significant in the agricultural history of Ocean Springs as the home of a family of locally reknowned horticulturalists E. W. Halstead, Sr., a former Assistant Horiticulturalist for Cuba, and his son E. W. Halstead, Jr. who was in charge of horticultural work in New Mexico for five years and in Cuba for ten years, operated a highly successful nursery and orchard business. They cultivated pecan trees, Satsuma oranges, and grapefruit, all important crops in turn of the century Ocean Springs agriculture.
