

ORDER DIRECTING NOTICE OF A PROPOSED ORDINANCE OF THE CITY OF CLEVELAND, MISSISSIPPI TO ESTABLISH A HISTORIC LANDMARK, OR LANDMARK SITE, TO BE KNOWN AS THE AMZIE MOORE HOME; TO DESIGNATE THE DESCRIPTION AND BOUNDARY OF THE SUCH LANDMARK, OR LANDMARK SITE

Upon report and recommendation of the Cleveland Heritage Commission and upon motion made by Alderman Campbell, seconded by Alderman Burke, and unanimously adopted, it is ordered that the City Clerk give notice of the intention of the Mayor and Board of Aldermen of The City of Cleveland, Mississippi to adopt an ordinance which will establish a historic landmark, or landmark site, to be known as the Amzie Moore Home; to designate the description and boundary of the such landmark, or landmark site, by publication at least once each week for at least three consecutive weeks in *The Bolivar Commercial*, and in the manner and for the time provided by law, substantially as follows, to-wit:

LEGAL NOTICE TO ALL INHABITANTS, TAXPAYERS, AND PROPERTY OWNERS IN THE CITY OF CLEVELAND, MISSISSIPPI, AND OTHER PARTIES INTERESTED, IN THE ADOPTION OF A PROPOSED ORDINANCE OF THE CITY OF CLEVELAND, MISSISSIPPI ENTITLED SUBSTANTIALLY AS FOLLOWS: "AN ORDINANCE TO ESTABLISH A HISTORIC LANDMARK, OR LANDMARK SITE. TO BE KNOWN AS THE AMZIE MOORE HOME; TO DESIGNATE THE DESCRIPTION AND BOUNDARY OF THE SUCH LANDMARK, OR LANDMARK SITE; AND TO PROVIDE FOR THE PRESERVATION, PROMOTION, AND DEVELOPMENT OF SAID LANDMARK, OR LANDMARK SITE, BY REQUIRING THAT NO APPLICATION PROPOSING THE ERECTION, ALTERATION, RESTORATION, DEMOLITION, OR MOVING OF ANY STRUCTURE WITHIN OR UPON SAID LANDMARK, OR LANDMARK SITE, SHALL BE APPROVED UNTIL REVIEWED AND APPROVED BY THE CLEVELAND HERITAGE COMMISSION"

Pursuant to an order of the Mayor and Board of Aldermen of The City of Cleveland, Mississippi, adopted on February 5, 2008, notice is hereby given that at a regular meeting of said Board to be held at 6 o'clock p.m. on Tuesday, March 4, 2008, in the Board meeting room in the Mayor's Office in the City Hall of said City a public hearing will be held on the adoption of a proposed ordinance establishing a historic landmark, or landmark site, to be known as the Amzie Moore Home, and at which meeting and hearing all citizens and parties in interest will have opportunity to be heard in favor of or against said proposed ordinance providing for such historic landmark, or landmark site, the property within which and the boundary of which site are described as follows in said City in the Second Judicial District of Bolivar County, Mississippi, wherein references to conveyances, subdivisions, plats, and parcel designations are such as are on file in the Office of the Chancery Clerk of Bolivar County, Mississippi, at Cleveland, Mississippi and in the Office of the Bolivar County Tax Assessor and Collector in said City, to-wit:

That property in The City of Cleveland, Mississippi, in the Second Judicial District of Bolivar County, Mississippi, described as follows:

Lot Four (4) in Block One of the Edgewood Addition to The City of Cleveland, Mississippi, according to a map or plat of said Addition on file in the Office of the Chancery Clerk of Bolivar County, Mississippi, at Cleveland, Mississippi.
