The Farish Street Neighborhood Historic District incorporates 200 buildings located in a 125acre area in downtown Jackson. Arranged on a grid pattern, the narrow streets of the distric are bounded on all sides by wider streets. The area is further defined by Greenwood Cemetery on the east, railroad tracks on the west, and the Fortification Street overpass on the north. Farish and Mill streets, the two main north-south arteries, are predominantly commercial in character but become more residential north of Monument Street. Other streets are primarily residential, with small grocery stores dotting the neighborhood. A soybean-processing plant, an ice-cream plant, and a food-storage warehouse are three industries located in the district which also includes eight churches. Building height is low with commercial buildings being one or two stories high and dwellings usually only one story in height. Most commercial buildings are constructed of brick and most residences are frame. While the majority of residences date from the early twentieth century, a variety of vernacular building types and periods is represented. Two houses may possibly predate the Civil War. One is a Creolecottage type with undercut gallery and paneled posts (154 Monument St.) and the other is a five-bay cottage with central entrance (208 E. Cohea St.). Creole cottages ca. 1880 remain on Blair and Cohea streets, and a cluster of Queen Anne-style L-plan cottages with polygonal bays is located on West Church Street. Individual houses of the Queen Anne type are also scattered throughout the district. Shotgun cottages ca. 1903 line one block of Farish and Church streets. Shotgun cottages are enriched with a variety of architectural details, from board-and-batten to bungalow-style porches and exposed rafter-tails. Many are enlarged with a variety of additions and in some cases have become additions themselves. Another common house type is the one-family Bungalow-style cottage found in single-family, duplex, and fourplex forms.

The most striking physical changes to the area include the construction in 1957 of a fourlane road which carves an S-shape through the district, interrupting the grid pattern and separating parts of the community, and the construction in the 1940s and '50s of rental housi in the inner cores of blocks. Although some of this housing is architecturally compatible, some is substandard, and most units are too close together, resulting in a lack of open space Demolition has occurred in the area around Hamilton and Mill streets, creating new open space and several new buildings, and on West Monument Street, where a new supermarket and parking lots have been built. Only one of the churches has not been replaced by a new building. Two common but reversible alterations are the cladding of frame houses with asbestos and the replacement of original porch posts with metal pipe. Despite these alterations, the percentag of intrusions is at a low twenty percent, and the district maintains a cohesive intimate quality reflective of its early-twentieth-century growth and development.

Historically significant as an economically independent black community, the Farish Street Neighborhood Historic District is the largest such community in the state. The area retains historical associations with black professionals who achieved prominence on state, local, and national levels; black businessmen who owned their own shops; and black craftsmen who constructed many of the buildings in the district. Architecturally, the district is an excellent record of vernacular building types from ca. 1860 through the 1940s. The majority of the buildings were built between 1890 and 1930, reflecting the growth and prosperity of Jackson and the neighborhood during that period. The fact that two buildings are thought to be antebellum is also of paramount importance to the city, which retains only nine other structures believed to predate the Civil War.

Prior to the Civil War, much of the area now located within the historic district belonged to large estates. Because they appear too substantial to have been slave quarters, it is possible that the antebellum structures remaining in the district housed free blacks (twenty-two were listed in an 1860 Jackson city directory), but it is more likely that they were associated in some way with the large estates. Although there was some migration to the larger towns in Mississippi after the Civil War, most of the black population continued to remain in rural areas and occupations. The urban population, however, "possessed an importance out of proportion to its size" (Vernon Lane Wharton, <u>The Negro in Mississippi</u> [New York: Harper and Row, 1965], p. 107. Surveyed and subdivided in the 1870s, the land now located within the historic district became a segregated area for blacks by the 1890s, and by 1904 a local newspaper reported that:

the negroes were never so prosperous as now and more of them are launching business concerns than ever before...They are buying their own homes, thus putting themselves on an independent footing. The established banking institutions are carrying more deposits made by negroes than ever before in the state's history and the assessment rolls show that they are entering all classes of business. "The Negroes Prosperous," <u>Daily Clarion-Ledger</u> [Jackson, Miss.], Sept. 24, 1904, p. 3.

By 1908, one-third of the area of Jackson was owned by black, one-half of the black families owned their own houses, and over one-third of the homes in which blacks lived vere owned by blacks (D. W. Woodard, <u>Negro Progress in a Mississippi Town: Being a Study of Conditions in Jackson, Miss</u>. [Cheney, Pa: Committee of 12 for the Advancement of the Interests of the Negro Race, 1908]).

ne of the wealthiest black residents of Jackson was Dr. Sidney D. Redmond, whose house ithin the district still stands at 229 East Church Street. Physician, businessman, and inker, Redmond was president of the American Trust and Savings Bank, one of two black nks established in Jackson by 1904; a stockholder in three banks controlled by whites nd in one of the power-and-light companies; chairman of the state Republican executive

Contributing buildings may be key elements of the streetscape which possess outstanding architectural importance and integrity or may be "part-of-the-scene" buildings without outstanding significance but whose appearance is compatible in terms of materials and scale. A marginal building is one which has some features which diminish its architectural integrity but which still maintains some redeeming elements such as scale and reversible alterations. A building considered an intrusion is one which has been altered to such degree that its original character is irretrievably obscured and/or its scale and materials are incompatible.

C. L. Barnes, dentist and president of the Jackson Negro Chamber of Commerce, at 920 Farish Street

Carpenters, brickmasons, plasterers, and other craftsmen were well represented in the district, and in 1908 it was reported that "in the plastering trade the negro workmen have no white competitors" (Woodard, p.7). Self-taught contractor George Thomas, now ninety-six years old and still living in the district, is well known for his buildings throughout the city. And Robert Rhodes constructed the stucco Bungalow-style cottages which line Cohea and Blair streets near his own home.

A variety of successful businesses were conducted on Farish Street, termed by the <u>Clarion-Ledger</u> in 1915 "one of the most progressive, growing business streets in the capitol city" (<u>Daily Clarion-Ledger</u> [Jackson, Miss.], Mar. 9, 1915) and known later as the Beale Street of Jackson. Many outstanding brick commercial buildings line the street. Even more important than the individual buildings, however, is the locally unique combination of residential and commercial buildings. This mixture, together with narrow streets, provides an early twentieth-century atmosphere no longer found in other commercial areas of Jackson. Buildings on lower Lamar Street and East Amite Street while not associated with the black history of the area, have been included within the district because they maintain the scale and character of commercial buildings in the district. In addition, buildings here form a buffer from the larger downtown buildings east of Farish Street and visually act as a prelude to the commercial vista which appears when one turns the corner from Amite Street onto Farish Street.

10 - VERBAL BOUNDARY DESCRIPTION

Beginning at the northwest corner of Amite and Lamar Streets the boundary moves west down the north side of Amite Street to Roach Street where it moves north to West Griffith Street. It then moves west, then south then west and south again to Amite Street, zig-zaging behind buildings on West Griffith and Mill Streets and reaching Mill Street at the northeast corner of Mill and Amite. It then moves north along the east side of Mill Street and jogs to the west to incorporate the large building on the McCarty Holman The line then moves east to the center line of Mill Street where it moves propertv. north for approximately 100 feet. The line then zig-zags northeast to exclude modern buildings and parking lots on Mill Street. It meets West Monument Street and moves west crossing Mill Street then moves north approximately 300 feet to include buildings facing Mill Street. The boundary then moves west to the railroad right-of-way which it follows in a northerly direction for approximately 350 feet. The boundary then moves east to the east side of Mill Street, then north to Fortification Street until it meets North Farish Street. The boundary is then gerry-mandered to include properties on Blair Street and Fortification Street moving from the rear property limits of Davis Street properties to the front limits of Fortification Street properties. The line then meets Lamar Street approximately 150 feet north of Davis Street. The line proceeds south to the south side of Cohea Street where it moves west to the east side of Blair Street. It moves south along Blair Street excluding a proposed housing project area to the east. The boundary moves east at the southern boundary of the proposed redevelopment area crossing Dreyfus Street where it moves south approximately 50 feet, then east 250 feet, then north 175 feet and east again for another 250 feet where it meets Lamar The boundary then moves south along Lamar Street to Church Street where it Street. follows the north side of Church Street west for about 200 feet. The line then moves south and then west to George Street excluding several modern buildings. The line moves east along George Street to include all buildings on the south side of the street and then moves south and then southeast across High Street to John Hart Street where it excludes a concrete block garage behind Smith Robertson School. It jogs south to meet East Hamilton Street excluding an intrusively altered building on the north side of Hamilton then moves west along the north side of East Hamilton Street for about 200 feet. The line then moves west to the Seale Lily property then south crossing East Griffith and continuing south behind commercial buildings fronting Farish Street. The boundary then moves east to Lamar Street running behind buildings fronting Amite Street. At Lamar Street the line moves south to the beginning point.
