

ARCHITECTURAL DESCRIPTION:	NAME: Glenn Swetman House
The Glenn Swetman House is a large, two-story, hip-roof, late-Georgian Revival, brick residence. Its symmetrical facade (south elevation) is dominated by a central recessed, distyle porch with modified Corinthian columns in antis which support a full entablature and frame a finely detailed fanlighted entrance. Two pairs of transomed French doors flank the central porch and give access from the interior to a balustraded terrace across the front. Symmetrical, one-story, flat-roof wings slightly intersect the front corners of the main building block and extend forward to enclose the ends of the front terrace. The west wing provides additional rooms for the house while the east wing consists of a colonnaded (and now screened) porch; both wings have iron roof balustrades which match those of the terrace. Biloxi's only historical example of the Georgian Revival style, the Glenn Swetman House was built by the promoters of the Miramar Subdivision, Home Haven on the Gulf, Inc. It is believed to have been a model home.	
The house, which contains extensive collections of fine art, glassware, antiques, and Biloxi memorabilia, has been bequeathed to the City of Biloxi by the Swetman family for use as a local history museum.
