Describe the present and original (if known) physical appearance

The Mollie Clark House

The Mollie Clark House which faces north is located at 2221 Yazoo Street, Pickens, MS. It is one of the finest Colonial Revival Houses in Holmes County. This two story, frame house which is built over a small ridge is set upon brick piers which are a full story at the rear. The multi-gable hipped roof is pierced by four interior chimneys and a molded cornice and freeze encircle the whole house. The windows are double-hung sash, one-over-one.

A one story kitchen ell is on an axis with the east elevation of the main block. A small porch with entrance to the kitchen utilizes the angle between the two units. The porch on the kitchen ell, and double gallery on the rear or south elevation of the main block are supported by box columns, and these are joined by a simple rail. Also, a straight flight of steps connects the upper and lower galleries.

The three bay northly facade is fronted by a one story gallery that is supported by ten lonic columns. A full two story height portico covers the formal entrance and gallery. This giant order pedimented portico is supported by a pair of fluted Corthian Columns on either side of the entrance. The entrance consists of doubled leaf doors, glazed and framed by leaded glass transom and side lights. The leaded glass sidelights are placed over molded panels. The whole of which is enframed by pilasters supporting a full molded entabalature. There is a second story doorway of similar, but plainer design, above the main entrance.

The floor plan of the main block, unaltered, consists of a central hall with two rooms on each side. The same arrangement is present on both floors, and the stairway runs along the east wall of the central hallway. The two downstairs rooms on the west side of the hallway, are the parlor in the northwest corner with sliding doors, and a bedroom. In the extreme southwest corner of the house is the bathroom with separate water closet and bathing facilities. The rooms on the east side are the library with sliding doors which open into the central hallway; and, the dining room which connects with the kitchen and the central hallway. Upstairs, there are four bedrooms, and a bathroom, like downstairs, at the southwest corner of the house.

Remarkable features about the house is that all the rooms contain the original light fixtures which are a combination of both gas and electricity. The wooden mantels, bathroom fixtures (laboratories and bathtubs) have remained intact and in position.

On the south lawn a two room, four bay framed servant's quarters, and further back in the rear yard is the frame gashouse which has been moved from its original location.

Statement of Significance (in one paragraph)

Mollie Clark Statement of Significance

The Mollie Clark House built Ca. 1909, is one of the best documented Colonial Revival Houses in Holmes County. The house is also significant for its historic association with the development of Pickens, Mississippi, during the early part of the twentieth century.

Mary Ann (Mollie) Clark was an active civic leader in Pickens and a benefactor who contributed to the community's growth and development. She was part owner of Burton-Clark Merchantile Company which was located in the middle of the business district of Pickens. Miss Clark was very influential in deciding the financial aspects of the city since she was the controlling stockholder of the Bank of Pickens.

In 1903, she purchased the lot for her future residence, - shortly afterwards she began to make plans for her future home. Fortunately, her correspondence concerning the planning and construction of the house has been preserved by her nephew, Mr. Billy Atkinson who is the owner and occupant of the house.

The family papers contain not only the correspondence with the architect W. K. Kitterham, Jackson, Mississippi, but "cutout pictures" of mantels from various catalogs; architectural specifications; cost estimates; contracts; and shipping receipts have been preserved. Therefore, almost every aspect of the building of the house can be documented.


After Miss Clark's death in 1940, the house was occupied by her sister, Mrs. Josephine Burton. In 1960, Mr. Atkinson acquired the house.

The basic integrity of the building has remained the same. This has probably been due to the fact the house has been in continous ownership by one family; which means its future preservation has been insured. This house is also the second residential building in Pickens to be nominated to the National Register of Historic Places.
