Describe the present and original (if known) physical appearance

The Southworth House is a two-story, three-bay, yellow brick mansion with hipped roof and wide, overhanging, bracketed eaves. A battered dormer with hipped roof is centered over the portico of the main block, from which extends a slightly recessed, southern wing with hipped roof. The easterly facade features a center-bay, flat-roof, one-story portico with full dentiled entablature sheltering the entrance doorway. The portico is supported by brick piers set in antis with round columns that are echoed on the facade by brick pilasters, in front of which are freestanding round columns. The original roof balustrade of the portico has been removed and stored until it can be repaired. The entrance doorway consists of double-leaf, multi-light, glazed doors set within matching sidelights and a multi-light transom. The center-bay second-story doorway is filled with narrower glazed doors also set within sidelights and transom. The end bays of the main block of the house are bordered with brickwork panels having stone or cement corner blocks and are filled with an arrangement of three windows having infine-over-one, doublehung sash.jeTwo, cast-stone or cement plaques adorn the facade and are located between the first and second-story window openings. The southern, recessed wing features a first-story entrance sheltered by a bracketed shed-roof hood with three, multi-light, glazed doors set beneath a multi-light transom. The window of the wing's upper bay is filled with three casement sash set beneath a multi-light transom.

A hipped-roof garage is located at the southwestern corner of the property.

Statement of Significance (in one paragraph)

An eclectic early twentieth century residence, the Southworth House exhibits certain characteristics associated with the Italian Renaissance Style such as a low-pitched, hipped, tile roof; bracketed, wide overhanging eaves; and a deep classical portico with roof balustrade (now removed and stored). Constructed in 1922, the house is one of the most architecturally significant of the Greenwood buildings designed by local architect Frank R. McGeoy. A native of Memphis, Tennessee, McGeoy deisgned many Greenwood buildings that were constructed in the first quarter of the twentieth century, including the First Methodist Church Sunday School Building, the temple building for Congregation Ahavath Rayim, and the Wesley United Methodist Church. The integrity of the Southworth House is outstanding and includes such unusual survivals as the original wooden benches that flank the entrance doorway.
