ARCHITECTURAL DESCRIPTION:

Two-and-a-half-story frame Queen Anne residence facing west toward the railroad tracks. Steeply pitched truncated hipped roof with irregular gabled projections featuring a two-and-a-half-story octagonal tower with tent roof at the northeast corner. Irregular fenestration on both stories of the facade. Double-leaf central entrance topped by transom. One-story gallery, supported on attenuated, modified Tuscan columns, across facade with balustraded porch on second story. One exterior chimney. Kitchen added to rear in 1907. Outbuildings include cottage to immediate rear of property (220 Myrtle Street).

Cottage to rear (220 Myrtle Street).

LANDSCAPE FEATURES:

Huge magnolia in front of residence planted by Mrs. Clark, wife of man who laid out streets for city.

STATEMENT OF SIGNIFICANCE:

The Berryhill House is an excellent example of Queen Anne architecture and is one of Magnolia's four Queen Anne residences. In addition, it is the only one of the city's extant Queen Anne residences located outside of the prosperous Southtown neighborhood and in Magnolia's more modest northern neighborhood and serves as a stylistic model of the Queen Anne style for the northern section of town. The Berryhill residence exhibits many high-style Queen Anne details—such as monumental tower, a wrap—around porch with a second—story balustraded porch, and decorative stickwork—and is an outstanding building within the context of Magnolia's historic resources.
