7. DESCRIPTION

Located one-and-one-half blocks northeast of the Copiah County Courthouse on North Ragsdale Avenue (formerly West Railroad Avenue), the Illinois Central Railroad Passenger Depot in Hazlehurst is a onestory, brick-veneered building resting on a concrete foundation and crowned by a hip roof with widely overhanging, flared eaves. The walls are finished with brick laid in running bond, with a soldier course at the roofline. A concrete belt course encircles the building and serves as window sills. The building was constructed circa 1925 and retains a high degree of architectural integrity.

The west elevation, which faces Ragsdale Avenue, has ten bays. All window openings are Craftsman-style, three-over-one, double-hung sash unless otherwise described. From left to right (north to south) the openings are as follows: short, paired windows; paired windows; double-leaf panelled and glazed doors topped by a five-light transom; paired windows; a box bay having two short windows; paired windows; double-leaf, panelled and glazed doors with a five-light transom; paired windows; and a sliding freight door with five-light glazed panel in the upper section.

The east, or track side, elevation has nine bays, which contain from left to right (south to north) a sliding wood freight door with 10light upper glazed panel; paired windows; double-leaf panelled and glazed doors topped by a five-light transom; paired windows; a boxed observation bay crowned by a gable-on-hip roof and containing a trio of three-over-one windows and two two-over-one windows; paired windows; double-leaf panelled and glazed wood doors with a five-light transom; and two pairs of windows.

The north elevation contains two bays having short, paired, threelight windows with concrete sills. The south elevation has three bays: the center bay has a single, short window while the outer bays have paired windows.

The interior of the building has a linear plan, containing from south to north, the luggage and freight area, the "colored waiting room," ticket office, "white waiting room," and the original bathrooms. The wall between the luggage and freight area and the "colored waiting room" did not originally open into the remainder of the depot, but a doorway and window opening have been added to make this area usable as shop space. five-panel doors with plain trim and molded lintels, and window trim. The original flooring is extant in half of the building, and the southernmost room retains its beaded board walls and ceilings. 8. STATEMENT OF SIGNIFICANCE

The Illinois Central Railroad Passenger Depot in Hazlehurst is locally significant under Criterion A in the area of transportation, representing the importance of rail transportation to the history and development of Copiah County. Rail transportation was vital to the economy of the county, providing ready access to markets for agricultural products and manufactured goods. In addition to transporting goods to market, the Illinois Central Railroad played an important role in the truck farming industry by developing specialized facilities and services to assist growers and local shippers. The Hazlehurst depot derives further significance from the fact that it is the only extant depot in Copiah County. The period of significance extends from circa 1925, when the depot was built, to 1945, the end of World War II and fifty years prior to the current (The associated historic context developed in the MPS cover date. document entitled "Historic and Architectural Resources of Copiah County, Mississippi" and represented by this property is "Copiah County's Development from the Post-Bellum Period to the End of World War II, 1866-1945.")

The first railroad line through Copiah County, the New Orleans, Jackson, and Great Northern (NOJ&GN) Railroad, was completed on March 31, 1858, and Hazlehurst was established about that time along the rail line. The Illinois Central Railroad purchased the assets of the NOJ&GN in 1877, merging that line with the Mississippi Central to form the Chicago, St. Louis and New Orleans Railroad, which was controlled by the Illinois Central and subsequently consolidated into that system in 1882.

Although three rail lines historically ran through Copiah County, only the old NOJ&GN (now Illinois Central) line has not been abandoned. The tracks of the other two lines through the county have been removed. (See the MPS cover document for a history of the railroad in Copiah County.) The only depot remaining in Copiah County is the Illinois Central Railroad Depot in Hazlehurst. The depot retains a high degree of architectural integrity and currently houses a gift and frame shop. **United States Department of the Interior** National Park Service



10. GEOGRAPHICAL DATA

<u>Verbal Boundary Description</u>: A parcel of land situated in the SW 1/4 SW 1/4 of Section 3, Township 10 North, Range 8 East, City of Hazlehurst, Copiah County, Mississippi, described as follows: From a point in the center of Green Street, said point being 150.0 feet westerly from the center of the northbound track of the Illinois Central Gulf Railroad; thence run southerly and parallel to said railroad and the east right-of-way line of Ragsdale Street for 156.0 feet to the point of beginning; thence continue south along the east line of Ragsdale Street for 174.0 feet; thence turn left through an angle of 90 degrees and run easterly for 110.0 feet, more or less, to a point that is 25 feet westerly from the center of the southbound track; thence run northerly and parallel to the southbound track for 174.0 feet; thence turn left through an angle of 90 degrees and run westerly for 110.0 feet, more or less, to the point of beginning.

<u>Boundary Justification</u>: The boundary being nominated includes the depot and its immediate setting and is the parcel of land presently owned by the current property owner.
