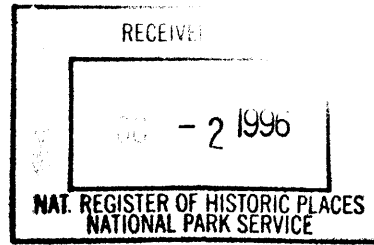

**7. DESCRIPTION**

A landmark in the town of Wesson, Mississippi, the Dr. Robert W. Rea House is located on the southeast corner of South Main and Church streets. Situated on an entire city block overlooking downtown Wesson, the house is surrounded by beautiful magnolia, palm, oak, azalea, crepe myrtle, dogwood and other indigenous trees and flowering shrubs, most of which were planted by Dr. Rea. A brick sidewalk laid in the herringbone pattern leads from Church Street to the main (north) facade.

The one-story, frame house is constructed in a combination of the Greek Revival, Italianate, and Gothic Revival styles. The house is crowned by a complex gable roof that is pierced by four massive brick chimneys with corbelled caps. Ornate brackets with drop pendants trim the gables and eaves of all but the rear elevation. Jigsawn gable ornaments and ogee-arched ventilators also appear in the gables. Constructed entirely of cypress, the house rests upon brick foundation piers, which are in-filled with brick. The outside walls are finished with lapped weatherboards, while the walls protected by porches and the gables on all but the rear elevation are finished with horizontal tongue-in-groove flush board.

The main (north) facade has a full-width, undercut gallery that features box columns with molded capitals, a jigsawn balustrade, and a wooden deck. The roof of this facade is pierced by a central gable trimmed with brackets and a jigsawn gable ornament, and in the gable is an ogee-arched ventilator and flush-board siding. The central entrance is a single-leaf, panelled and glazed door topped by a single-light transom and framed by four-light sidelights over molded panels. The frontispiece is composed of pilasters supporting a full entablature. At the side of the door is a white glass knob that, when pulled and then released, sounds a loud gong to alert the occupants of a visitor. To each side of the central entrance are two floor-length (11'0"), six-over-nine, double-hung windows. Each of the windows have screen doors and louvered blinds.

Additional porches appear on the north ends of both side elevations. These porches have wooden decks, jigsawn balustrades, box columns with molded capitals, and flat roofs trimmed with brackets. Two floor-length, six-over-nine windows open onto the porch on the east elevation. The porch on the west elevation is L-shaped and has three floor-length windows and two doors opening onto it. Other windows throughout the house are six-over-six, double-hung sash protected by louvered blinds.

The house interior is a central hall, double-pile plan, with a western ell and two rear ells, creating a U-shaped rear elevation. The central hall is 8' by 40' in size and is finished with 1'1" baseboards, wainscoting, molded plaster cornices and ceiling medallions, and a plaster arch. The

arch is supported by ornate plaster consoles and is decorated with plaster rosettes and an oil lamp hanger. At each end of the hall are identical entrances composed of single-leaf, panelled and glazed doors framed by sidelights and a transom. Each of the doorways leading from the hall into the four main rooms contains a panelled door topped by a massive one-light transom.

The interior contains a total of seventeen rooms and three hallways. There are six bedrooms, four bathrooms, a dining room, living room, formal parlor, kitchen, a large pantry (presently being used as an additional kitchen), laundry room, a sun room, one large interior hall, two small interior halls, and seven closets, which are rarely found in houses of this era.

Significant interior features include seven mantelpieces with Tudor-arched openings framed by pilasters, cypress flooring, plastered walls, 12'6" ceilings, molded baseboards (1'1" height), thirty-six windows (most with original glass), large transoms above all doors, plaster ceiling molding, three large plaster ceiling medallions, and white glass door knobs and brass hardware on all doors.

Located in the yard at the rear of the house is a one-story, frame, side-gabled, two-by-one-bay, "saddlebag" form building. This building originally was used as a servants quarters, but today serves as an office and guest bedroom. The roof is clad in standing seam metal and is pierced by a central interior chimney, and in the eaves are decorative brackets. On the north elevation are two single-leaf doors. Each of the two rooms has a fireplace, and a bathroom has been added between the rooms. Contained in the building are many artifacts of the Mississippi Mills and the Rea and Oliver families. This building is a contributing element.

A car/storage building is located on the southwest corner of the property on the site of a mule barn that was torn down in the 1930s. Some time in the 1930s the existing car/storage building was constructed using the cypress lumber from the old mule barn. A noncontributing resource, the building is a three-car shed with two storage rooms added on, and measures approximately 33'x33'.

**8. STATEMENT OF SIGNIFICANCE**

Built in 1874, the Dr. Robert W. Rea House derives its significance from its architectural character (Criterion C), being a good example of transitional architecture and representing the change in popular taste from the Greek Revival style to the picturesque Italianate and Gothic Revival styles. The town of Wesson is distinguished by a number of early post-bellum cottages that display transitional Greek Revival features along with more eclectic Victorian design elements. Many of these houses have side-gabled roofs with intersecting cross gables, and on the main facades these cross gables are either centrally located or are on one or both ends. Those houses with central gables typically have full-width, recessed galleries with box columns, and the Dr. Robert W. Rea House is an example of this type. Many of Wesson's transitional cottages have jigsawn balustrades on the porches, and a few feature Italianate brackets in the friezes. The Dr. Rea House is distinguished from the other Wesson examples in that it is constructed in a variety of three styles: Greek Revival, Italianate, and Gothic Revival. In fact, there are few known Mississippi examples of residences built in a combination of these three styles. (The associated historic contexts developed in the MPS cover document entitled "Historic and Architectural Resources of Copiah County, Mississippi" and represented by this property are "Copiah County's Development from the Post-Bellum Period to the End of World War II, 1966-1945" and "Development of Copiah County's Towns, 1823-1945.")

In the mid-nineteenth century, American architecture was undergoing a transition from the classical to the picturesque. In Mississippi, drawing from the popular styles of the day, houses of a conventional Greek Revival form sometimes incorporated romantic Gothic and Italianate ornamentation. Other known extant Mississippi houses displaying a combination of these three styles include the Jenkins H. Welch House near Hazlehurst in Copiah County; the Dampeer House in Crystal Springs, also in Copiah County; White Arches, Shadowlawn and Colonnade in Columbus; the Old Homestead in Aberdeen; the Parker House in Canton; and the R.W. Chandler House in Okolona.

While the form of the Rea House and much of its character is that of the classical Greek Revival mode, brackets in the Italianate style and jigsawn balusters, ogee-arched ventilators, and mantelpieces with Tudor-arched openings in the Gothic mode adorn the house. The interior has many fine features, such as a decorative plaster arch and wainscoting in the central hallway, richly molded plaster cornices and ceiling medallions, and wide baseboards.

The Rea House was built by Captain and Mrs. William Oliver as a wedding gift for their daughter, Rilla, and Dr. Robert W. Rea, who were married in December 1874. The house was designed by Rilla Oliver Rea, who was a gifted artist. As discussed in the MPS cover document

(pages E-29 through E-31), Captain Oliver was a major stockholder, General Manager, Secretary and Treasurer of Wesson's Mississippi Mills from 1871 until his death in 1891. Dr. Rea was a medical practitioner in Wesson and in the surrounding area for some forty years. Dr. Rea practiced medicine from this house, where all of his medical books still remain. In addition to practicing medicine, Rea owned about seventeen hundred acres of good timbered and tillable land, all of which he acquired by his own efforts. He was a member of the A.F.&A.M., and he and his family were members of the Wesson Presbyterian Church.

In 1874 or 1875, the Rea House was furnished with very fine furniture, much of which remains in the house. Progress has been made in returning some original pieces of furniture that had been removed. The home is presently occupied by Mr. and Mrs. Henry F. (Hank) Smith, he being the great-grandson of the late Dr. and Mrs. Robert W. Rea.

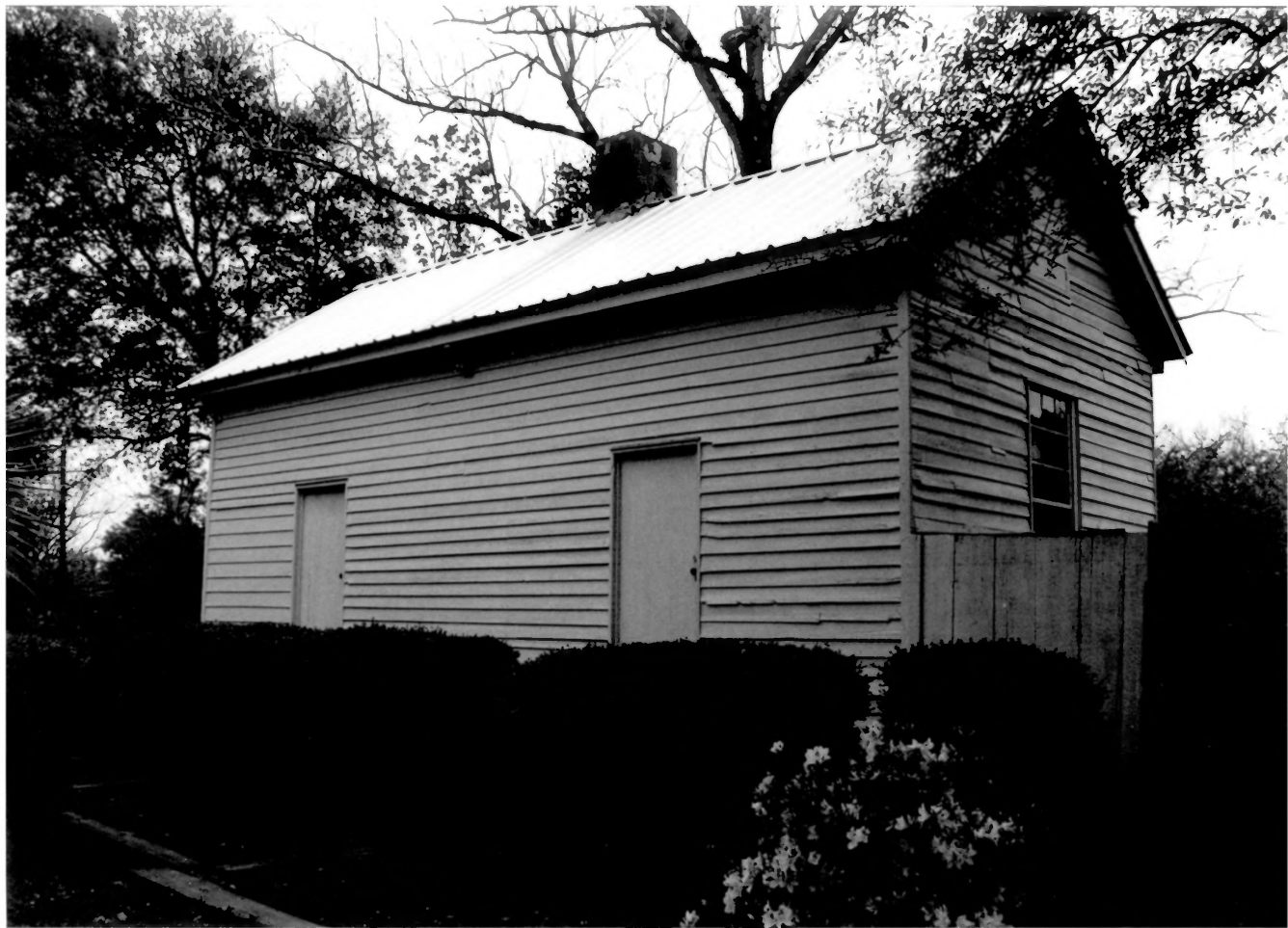
